Dear Friend of CASA of South Central KY,


CASA (Court Appointed Special Advocates) of South Central KY, Inc. is a nonprofit agency dedicated to preventing and eliminating further trauma to children. Specifically, CASA works to prevent child victims of abuse, neglect, and dependency from further abuse by providing trained community volunteers to advocate for them in the foster care and the family court systems. The CASA concept is based on the commitment that every child has the right to a safe, permanent home as soon as possible.

We are currently requesting donations for **Holiday Bash 2017** and **Boogie Down Bourbon Street 2018** silent and live auctions.
